

## Scrapbook Creations April 7-10, 2022

### Weekend Retreat

- When:** Noon on Thursday, April 7<sup>th</sup> or 9:30 AM on Friday, April 8<sup>th</sup> through 3 PM on Sunday, April 10<sup>th</sup>, 2022
- Where:** Hampton Inn, East Aurora, NY  
(1 hour and 30 min from downtown Rochester)
- What:** 2 1/2 or 3 1/2 full days of cropping fun, prizes, goodie bags, and accommodations. Food and beverages are on your own.

Prices as follows: All prices are subject to 8.75% sales tax.

**\*\*\*Early Bird Discount: Save \$10 if you are paid in full by February 10, 2022!\*\*\***

Hotel Rooms: 2 double beds, private bathroom, small refrigerator, microwave  
\$379 per person, 1 per room Fri - Sun (\$514 Thursday check in)  
\$259 per person, 2 per room Fri - Sun (\$329 Thursday check in)  
\$209 per person, 3 per room Fri - Sun (\$269 Thursday check in)  
\$189 per person, 4 per room Fri - Sun (\$229 Thursday check in)

Note: Roommates need to be arriving on the same day. If some roommates would like to arrive a day earlier, the price for those arriving a day early will be more than what is listed above. See Keri for specific prices.

#### Meals:

Breakfast is included each day. Coffee, tea, and water are available all the time as well. Each guest room includes a refrigerator and microwave. You are welcome to bring your own food. There are also many eateries nearby, many within walking distance, and some will deliver.

#### Cropping space:

Each cropper will get 6' of table space. (Either a 6 foot table to yourself or a 6' section of a larger table.) All croppers will have access to electricity. Please mark all tablemate preferences on registration form to ensure that you can sit together.

#### Payment:

\$100 is due at registration to reserve your guest room and seat. No rooms or seats will be reserved without \$100 down. Final balance is due no later than March 10, 2022. If not paid by March 10, 2022, you forfeit your guest room and seat at the retreat with no refund. Save \$10 off your retreat package if you are paid in full by February 10, 2022. No early bird discounts will be given when payment is received electronically or snail mail is postmarked after February 10, 2022. Customer will be responsible to cover any charges for returned fees or bounced checks.

### Impact of Cancellation on Roommates:

Please understand that if someone in your guest room cancels, your rate will increase and you will be responsible for paying the difference. On the flip side, if you add a person to your guest room, refunds will be given for the rate difference.

### Cancellation Policy

#### Cancellation 60 or more days prior to the event

Options:

- If you find a replacement that will stay in the same guest room, arrive on the same day, and sit at the same table, you will receive a full refund less a \$25 cancellation fee. If we have a waiting list, we can assist in finding a replacement.
- Receive a full refund, less a \$50 cancellation fee.

#### Cancellation 59 - 30 days prior to the start of event

Options:

- If you find a replacement that will stay in the same guest room, arrive on the same day, and sit at the same table, you will receive a full refund less a \$50 cancellation fee. If we have a waiting list, we can assist in finding a replacement.
- Receive a full refund, less a \$100 cancellation fee.

#### Cancellation 29 - 8 days prior to the start of event

Options:

- If you find a replacement that will stay in the same guest room, arrive on the same day, and sit at the same table, you will receive a full refund less a \$100 cancellation fee.
- If you find a replacement that will not be staying in the same guest room, arriving on the same day, and sitting at the same table, an additional transfer fee of \$50 will be applicable.
- No refunds will be given without a replacement. If we have a waiting list, we can assist in finding a replacement.

#### Cancellation with less than 7 days notice and "No Shows"

- No refunds or credits will be given.

\*\*Please note that refunds will be sent to the person listed on the registration form, regardless of who made the payments for deposit and/or balance.
